**NOTICE OF EIGHTH ANNUAL GENERAL MEETING**

**NOTICE IS HEREBY GIVEN** that the Eighth Annual General Meeting of the Company will be held at 51 Cuppage Road #09-01 StarHub Centre Singapore 229469 on Thu 27 Apr 2006 at 10.30 a.m. to transact the following business:

**AS ORDINARY BUSINESS**

1. To receive and adopt the Audited Accounts for the year ended 31 Dec 2005 and the Directors' and Auditors' Report thereon. **Resolution 1**
  
2. To declare a final tax exempt (one-tier) dividend of 0.5 cents per share, and a special tax exempt (one-tier) dividend of 2.0 cents per share for the year ended 31 Dec 2005. **Resolution 2**
  
3. To re-elect Mr Bertie Cheng, who is retiring in accordance with Article 91 of the Company's Articles of Association. **Resolution 3**

4. To re-elect Mr Clive Lim Chai Hock, who is retiring in accordance with Article 91 of the Company's Articles of Association. **Resolution 4**

**AS SPECIAL BUSINESS**

To consider and, if thought fit, to pass the following resolutions as Ordinary Resolutions:

8. Authority to issue shares (General) **Resolution 8**  

That, pursuant to Section 161 of the Companies Act (Cap. 50), and the listing rules of the Singapore Exchange Securities Trading Limited ("SGX-ST"), authority be and is hereby given to the Directors of the Company to:

(a) (i) issue shares in the capital of the Company ("shares") whether by way of rights, bonus or otherwise; and/or (ii) make or grant offers, agreements or options (collectively, "Instruments") that might or would require shares to be issued, including but not limited to the creation and issue of (as well as adjustments to) warrants, debentures or other instruments convertible into

shares, at any time and upon such terms and conditions and for such purposes and to such persons as the Directors may in their absolute discretion deem fit; and

(b) (notwithstanding the authority conferred by this Resolution may have ceased to be in force) issue shares in pursuance of any Instrument made or granted by the Directors while this Resolution was in force, provided that:

(i) the aggregate number of shares to be issued pursuant to this Resolution (including shares to be issued in pursuance of Instruments made or granted pursuant to this Resolution), does not exceed 50% of the issued share capital of the Company (as calculated in accordance with sub-paragraph (ii) below), of which the aggregate number of shares to be issued other than on a *pro rata* basis to shareholders of the Company (including shares to be issued in pursuance of Instruments made or granted pursuant to this Resolution) does not exceed 20% of the issued share capital of the Company (as calculated in accordance with sub-paragraph (ii) below);

(ii) (subject to such manner of calculation as may be prescribed by the SGX-ST) for the purpose of determining the aggregate number of shares that may be issued under sub-paragraph (i) above, the percentage of issued share capital shall be based on the issued share capital of the Company at the time this Resolution is passed, and adjusting for: (1) new shares arising from the conversion or exercise of any convertible securities or share options or vesting of share awards which are outstanding or subsisting at the time this Resolution is passed; and (2) any subsequent consolidation or subdivision of shares;

(iii) in exercising the authority conferred by this Resolution, the Company shall comply with the provisions of the Listing Manual of the SGX-ST for the time being in force (unless such compliance has been waived by the SGX-ST) and the Articles of Association for the time being of the Company; and

(iv) (unless revoked or varied by the Company in General Meeting) the authority conferred by this Resolution shall continue in force until the conclusion of the next Annual General Meeting of the Company or the date by which the next Annual General Meeting of the Company is required by law to be held, whichever is the earlier.

9. Authority to issue shares under the TeleChoice Pre-IPO Share Option Scheme

**Resolution 9**

That authority be and is hereby given to the Directors to allot and issue from time to time such number of shares in the Company as may be required to be allotted and issued pursuant to the exercise of options under the TeleChoice Pre-IPO Share Option Scheme ("Pre-IPO Scheme"), provided that the aggregate number of shares to be issued pursuant to the Pre-IPO Scheme does not exceed 20,000,000 shares.

10. Authority to grant options and issue shares under the TeleChoice Post-IPO Employee Share Option Scheme

**Resolution 10**

That authority be and is hereby given to the Directors to offer and grant options in accordance with the rules and terms of the TeleChoice Post-IPO Employee Share Option Scheme ("Post-IPO Scheme") and to allot and issue from time to time such number of shares in the Company as may be required to be allotted and issued pursuant to the exercise of options under the Post-IPO Scheme, provided that the aggregate number of shares to be issued pursuant to the Post-IPO Scheme does not exceed 15% of the issued share capital of the Company from time to time.

### **Books Closure and Dividend Payment Dates**

Subject to shareholders' approval of the payment of the proposed final and special dividend ("Dividends") at the Eight Annual General Meeting to be convened on 27 Apr 2006, the Share Transfer Books and Registers of Members of the Company will be closed from 6 May to 7 May 2006, both dates inclusive. Duly completed transfers received by the Company's Registrar, M & C Services Private Limited, 138 Robinson Road #17-00 The Corporate Office Singapore 068906, up to 5 p.m. on 5 May 2006 will be registered to determine shareholders' entitlement to the proposed Dividends. In respect of ordinary shares in securities accounts with The Central Depository (Pte) Ltd ("CDP"), the Dividends will be paid by the Company to CDP which will, in turn, distribute the dividend entitlement to the shareholders. The proposed Dividends, if approved by shareholders, will be paid on 22 May 2006.

### **EXPLANATORY NOTES:**

- (a) Ordinary Resolution No. 3 is to approve the re-election of Mr Bertie Cheng, who is retiring by rotation, in accordance with Article 91 of the Company's Articles of Association. Upon re-election, Mr Bertie Cheng, who is considered independent for the purpose of Rule 704(8) of the Listing Manual of the SGX-ST, will remain as Chairman of the Remuneration Committee and Chairman of the Executive Committee.
- (b) Ordinary Resolution No. 4 is to approve the re-election of Mr Clive Lim Chai Hock, who is retiring by rotation, in accordance with Article 91 of the Company's Articles of Association. Upon re-election, Mr Clive Lim Chai Hock, who is the President and Executive Director, will remain as a member of the Executive Committee.
- (c) Ordinary Resolution No. 5 is to approve the re-election of Mr Lee Theng Kiat, who is retiring by rotation, in accordance with Article 91 of the Company's Articles of Association. Upon re-election, Mr Lee, a non-executive director, will remain as a member of the Remuneration Committee, the Nominating Committee and the Executive Committee. Upon Mr Lee's re-election, Mr Kwek Buck Chye will continue as alternate director to Mr Lee.
- (d) Ordinary Resolution No. 8 is to authorize the Directors to issue shares in the capital of the Company and to make or grant instruments (such as warrants or debentures) convertible into shares, and to issue shares in pursuance of such instruments, up to an amount not exceeding in total 50% of the issued share capital of the Company, with a sub-limit of 20% for issues other than on a *pro rata* basis to shareholders. For the purpose of determining the aggregate number of shares that may be issued, the percentage of issued share capital shall be based on the issued share capital of the Company at the time that Resolution 8 is passed, after adjusting for (a) new shares arising from the conversion or exercise of any convertible securities or share options or vesting of share awards which are outstanding or subsisting at the time that Resolution 8 is passed, and (b) any subsequent consolidation or subdivision of shares.
- (e) Ordinary Resolution No. 9 is to authorize the Directors of the Company to allot and issue shares in the Company pursuant to the exercise of options granted under the TeleChoice Pre-IPO Share Option Scheme ("**Pre-IPO Scheme**"). The Pre-IPO Scheme was adopted at an Extraordinary General Meeting of the Company on 7 May 2004. On 12 May 2004, pursuant to the Pre-IPO Scheme, the Company granted share options to eligible participants, to subscribe for an aggregate of 20,000,000 shares. Details of the Pre-IPO Scheme are set out at page 132 of the Company's prospectus dated 16 Jun 2004.
- (f) Ordinary Resolution No. 10 is to authorize the Directors of the Company to allot and issue shares in the Company pursuant to the exercise of options granted or to be granted under the TeleChoice Post-IPO Employee Share Option Scheme ("**Post-IPO Scheme**"). The Post-IPO Scheme was adopted at an Extraordinary General Meeting of the Company on 7 May 2004. Details of the Post-IPO Scheme are set out at pages 133-139 and Appendix IV of the Company's prospectus dated 16 Jun 2004.
