Nexwave Telecoms launches SunPage Internet Call Service

With a Nokia N80 Internet Edition and a SunPage International Calling Card, users can make international calls over WiFi broadband, both at home and abroad, at highly competitive SunPage International Direct Dial (IDD) rates.

Nexwave Telecoms, a leader in integrated telecommunications products and services, has offered affordable international calling services in Singapore under the well-known SunPage brand since 2000. To date, SunPage users have been required to contact a local dial-in point with a fixed line or mobile phone to access the SunPage IDD service. The introduction of alternative VoIP access not only improves user-friendliness — after activating the card on the Nokia N80 Internet Edition mobile device, the user simply picks a name from the phonebook and makes the call. SunPage customers can now also make calls from abroad without paying costly roaming or hotel call rates.

The service will be available with immediate effect. SunPage International Calling Cards are sold by authorised dealers such as 7-Eleven, Cheers and Singapore Post. Existing SunPage International Callings Cards are automatically enabled for the new service. For a limited period, special SunPage promo cards are available at the SunPage Shop in Plaza Singapura for Nokia N80 Internet Edition owners who wish to try out the service for free.

“We are pleased that Nexwave Telecoms has successfully developed and launched its international VoIP call service, offering pre-paid Internet calls, using the Nokia N80 Internet Edition, the first in a growing range of Nokia devices to support VoIP”, said David Watkins, Multimedia Sales Director, Asia Pacific, Nokia. “Mobilising the internet is a major strategic focus for Nokia.
